2021 Nominations for the SE Section



We are currently looking for ladies to run for the SE Section Board and Nominating Committee. As a SE Section Board Member, you will have a chance to guide the direction of our Section. You will help provide opportunities for our members to grow in their aviation dreams and support our chapters. The job is not a hard one, but an especially important one. If you have ever thought about serving at the Section level, please consider running for office.

I did want to point out that our members realize that it is important to support our Board Members. Our Section offers monetary support to our Board Members. Many of our members might not realize this benefit is available to our Board. Our Governor has funds to pay for most of her hotel and registration fees for Section Meetings and International Meetings plus funds to help with Chapter Outreach. There is also funding for Board Members when it comes to Chapter Outreach. I have learned while talking to other Section Governors, that not all Sections are able to provide this support to their Governors and Board Members. These funds might not cover all expense that our Governor or Board Members might have, but it does help defer the cost.

Below is a brief description of the positions. Feel free to reach out to our ladies who are serving now if you have any question about what is required.

Governor: Must be an active member and have served one term on the Board. The Governor runs section and board meetings. She will enforce the SE Section Bylaws and guide the officers and committee members to help them perform their duties. She can appoint committee chairmen, as needed. She will represent the SE Section at International Board of Director meetings. She will carry out the collective wishes of the members of the SE Section and be their spokesperson at international level.

Vice-Governor: Must be an active member. The Vice-Governor assist the Governor and works with the host Chapter of Section Meetings.

Secretary: Must be an active member. The Secretary takes the minutes of both Section Meeting and Board Meetings. She is responsible for all communication pertaining to Section Business. She is responsible for the Section charter, Articles of Incorporation, Bylaws, and SOPs.

Treasure: Must be an active member. The Treasurer is responsible for all incoming

and outgoing monies Section monies. She works with the Governor and the Board to create a budget which will be present to the membership for final approval. She will provide a financial report at Section meetings.

Directors: Must be an active member. The Directors work with the Governor to provide support to the Chapters.

Nominating Committee Member: Must be an active member. The Nominating Committee is responsible for recruiting members to run for office. They will work with the candidates to ensure the required nomination forms are submitted by the deadline. They will submit the names of all the candidates to the board.
